1. Introduction

- Matt Smith introduced everyone at the Armstrong Conference Room and those who called in.
- 2. Grady Core Values & CASS Project Team Introduction
 - JLL noted the importance and the need of the Grady CASS Project to the area.

3. Scope of Work

- JLL noted anyone that comes into the site will need to go through Skanska-Russell's safety orientation with no exceptions.
- JLL discussed PPE requirements when entering the site including vest, hard hat, gloves, face mask, safety glasses, and boots.
- JLL discussed the COVID-19 protocols when entering the site including a temperature check and wellness questionnaire.
- JLL noted that the Proposer will need to attend weekly OAC and scheduling meetings (pull plan meetings) on an as needed basis throughout the duration of the project.
- JLL requested that all Proposers submit sample pictures of projects including time stamps and area titles.
- JLL noted that this project has a target 30% of minority participation and any company bidding as a minority company needs to provide MWBE certification as shown in the RFP. Refer to "Appendix E Supplier Diversity" for further information.
- JLL discussed the scope of work for this RFP including aerial shots, pre-pour slab, overhead and in-wall MEP, and interior finishes.

4. Fee Structure and Breakdowns

• JLL requested to see the fee breakdown of each portion of work and the planned number of people on site.

- JLL noted that a permit will be needed if drones are being used and must go through City of Atlanta, Grady Hospital, Fulton-Dekalb County Hospital Authority, GA State University and the FAA.
- JLL highlighted the importance of photo documentation of the post-tension slabs on levels 1-4, the transfer girder on level 4 and the MEP rough ins.

- Award Recommendations Week of October 19,2020
 - JLL noted that after the Award Recommendation is announced the scope of work will begin immediately.

7. Misc./Open Discussion and Questions


- Question: What is the frequency for the wall photo documentation?
