INVITATION for QUALIFICATIONS GRADY BED EXPANSION BUNDLE 1 NINTH AND TENTH FLOOR A/B-WING / GRADY MEMORIAL HOSPITAL BUNDLE 2 NINTH, TENTH, ELEVENTH, AND TWELVETH FLOORS C/D-WING / GRADY MEMORIAL HOSPITAL BUNDLE 3 SEVENTH, NINTH, TENTH, ELEVENTH, TWELVETH FLOORS E WING FOURTEENTH AND FIFTEENTH FLOORS A/B/E WING

Grady Health System Department of Facilities Development is soliciting "Qualifications" A/E/C services to increase patient capacity.

- Bundle 1 is a backfill of existing space in the West Tower, following the relocation of the Georgia Cancer Center of Excellence to the Correll Pavilion in January, 2023. We anticipate this space to yield 52 critical care beds, all private.
- Bundle 2 is a backfill of existing space in the East, following the relocation of support functions. We
 anticipate this space to yield 122 acute care beds, all private except for two semi-private rooms per
 floor.
- Bundle 3 enables the relocation of support functions from the East Tower.

This is a multiple phased effort.

We anticipate work to commence in December for select portions of this overall effort.

Work is organized into three separate bundles in order to advantage redundancy of the planned renovations and allow multiple design and construction efforts to commence and proceed concurrently.

The primary scope includes

- construction of two new Critical Care units,
- renovations to two existing Med -Surg units,
- construction of four new Med-Surg units,
- construction of seven new office and support areas supporting this inpatient growth, and
- infrastructure supporting this inpatient growth.

A brief overview of the project is further into this document.

The project will be located in the main hospital at 80 Jesse Hill Jr. Drive, SE, Atlanta, GA 30303.

All A/E/C firms planning to partner and submit a proposal must be pre-qualified or submit a qualification to receive consideration.

To become qualified, please submit a qualifications package meeting the following requirements:

- List of three to five design-build projects of similar size and scale.
- Brief narrative of each of the referenced projects.
- Organization chart of your team
- One page CV or resume of each team member.

Additionally, qualification requires that Health System Diversity forms (posted separately), and registration with VendorMate, be completed and included in your response.

Please submit qualifications to George Smith by email, at <u>gcsmith@gmh.edu</u>, no later than Monday, October 17th @ 10:00AM. You will be notified by Tuesday, October 18th if you have met the threshold for being qualified.







All proposal presentations will be made, by team, for each Bundle Tuesday, November 1, 2022. Time and location to be determined.











FIGURE 01 – PHASE 1 NEURO FLEXIBLE ROOMS 9A/9B AND 10A/10B [BUNDLE 1]




FIGURE 02 – TYPICAL CRITICAL CARE UNIT 9B/10B


