 - b. Financial Standing Contractor must be able to provide three years of reviewed or audited financial statements. Contractor must demonstrate that no active liens have been filed against contractor in the past five years. Provide current debt ratio.
 - c. Regulatory and Ethical Compliance Contractor must not have been found in non-compliance with Georgia statutes or the standards and rules

set by the Ethics Commission of the State of Georgia. Contractor officers and principals must not be presently debarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded from transactions by any Federal department or agency.

- d. Insurance Coverage Contractor must comply with Schedule A (Attached).
- e. Bond Capacity Contractor to state bonding values committed and available.
- f. Licensing Contractor must hold a current Georgia General Contractor License.
- g. Safety Contractor must have a corporate safety program. Contractor must demonstrate an EMR less than 0.85 for at least three (3) years. All Superintendent level personnel are required to have Certified Healthcare Constructor (CHC) and current First Aid/CPR certifications. All foreman level personnel are required to have at least OSHA 30 training and current First Aid/CPR certification.
- II. Hospital Construction Experience
 - Capabilities Must be experienced with performing tenant improvements within an active healthcare setting without interruption to the facility.
 - b. Experience -
 - List of three to five healthcare clinic projects of similar size and scale.
 - Experience with hospital based Radiology projects.

 - Provide healthcare clinic owner representative references for each of the referenced projects.
